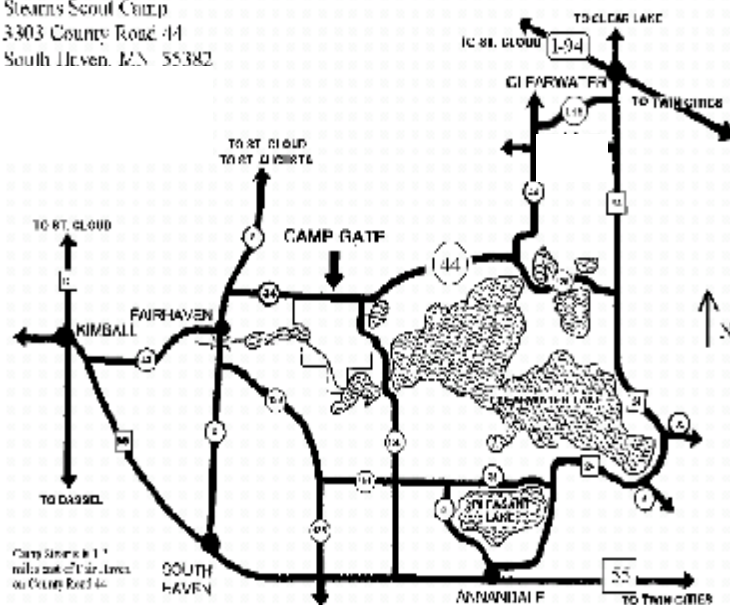

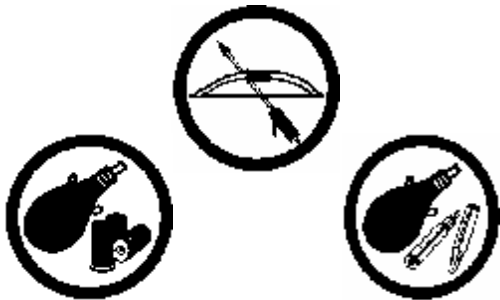
INFORMATION

Scouts who have partial merit badge cards and are needing to finish the RIFLE or SHOTGUN or ARCHERY Merit Badge have an opportunity to complete them at Stearns Scout Camp on October 20, 2007. Check in at camp is at the Whitewater Ranges.

A signed parental permission slip must be provided to the Range Officer in camp for rifle and shotgun participants (see back side of this form).

You may sign up for all three sessions if you have partials in those merit badges. You may sign up for multiple hours. NOTE: Scouts should not need more than 2 hours to complete any partial merit badge. You must bring your partially completed Merit Badge card to camp with you!!

The Event fee is \$5.00 for the day and should be included with your registration slip.



Rifle Merit Badge

Work sessions will be one hour in length. The ammunition fee is payable in camp and will be about \$0.25 per 10 rounds. Session options will be on the hour from 9 a.m. to Noon. (6-8 youth per hour can be accommodated.)

Shotgun Merit Badge

Work sessions will be 1 hour in length. The ammunition fee is payable in camp and will be about \$8.00 per 25 shots. Session options will be on the hour from Noon to 4 p.m. (2-3 youth per hour can be accommodated.)

Archery Merit Badge

Work sessions will be 1 hour in length. There is no ammunition fee. Session options will be on the hour from 9 a.m. to 4 p.m. (4-6 youth per hour can be accommodated.)
